National PTA and Free State PTA membership dues: while you should continue selling memberships and collecting dues, to be in "good standing" and to determine the number of delegates you may send to the Free State PTA Convention, you must remit dues for at least 10 members by March 31!

Leader To-Do List

- Personal Property Report due by 4/15; all PTAs must file ONLINE to maintain incorporation status (<http://bcptacouncil.org/personal-property-taxes>)
- PTA Council General Meeting, 4/30, 7pm (virtual)
- Share Council Scholarship Application due 5/1
- Publish your nominating committee's slate of officers; check your bylaws for specifics
- Elect officers for next school year; see bylaws for correct election month

Standards Of Affiliation (SoA)

In addition to paying member dues and providing officer contact information to Free State PTA (FSPTA), you must take care of the following:

- ✓ **BYLAWS:** Bylaws need to be reviewed at least every 3 years and submitted to FSPTA for approval.
- ✓ **FINANCIAL REVIEW (AUDIT):** All PTAs must conduct an annual financial review (due 10/30).
- ✓ **INSURANCE:** Every PTA unit in Maryland must have insurance coverage through AIM. Enrollment forms were emailed to all PTAs. Coverage ended 6/30/25.
- ✓ **IRS 990:** Every PTA must file annually by 11/15. If annual gross income was \$50,000 or less, you can submit the 990N e-postcard.
- ✓ **MARYLAND CHARITABLE SOLICITATIONS ACT:** As a charitable organization soliciting in MD, your unit must file documents with the Secretary of State. Registration is required prior to the commencement of solicitations (for new units) and an annual update is required.
- ✓ **INCORPORATION/MD PERSONAL PROPERTY REPORT:** All local PTAs must be incorporated in MD. To maintain your incorporation status, a Personal Property Report must be filed by 4/15 each year if your PTA owns any property or not.

For all shared documents, be sure to keep copies for yourself!

FSPTA requires that units submit SoA documents via Givebacks!

MARYLAND PERSONAL PROPERTY REPORT

Even though your unit likely owns no personal property, you must submit (online) a Maryland Personal Property Report Update every year to remain a corporation in "good standing" with the state. **This report is due on April 15.**

Filing this report is one of your unit's Standards of Affiliation (SoA). You need to file to make sure the state knows your unit/corporation is still in operation.

- **Annual Report must be filed by all PTAs. (NOTE: Annual Report form does not solicit income information and must be filed regardless of income.)**
- **Personal Property Tax Return must be filed only by those PTAs, if any, that actually own personal property.**

The simplest method to file both the Annual Report and Personal Property Tax Return is through [Maryland Business Express \(MBE\)](#). ***As you answer the prompts in filing the Annual Report electronically, MBE will automatically identify whether a Personal Property Tax Return is required.***

All business entities registered to do business in Maryland MUST file an Annual Report and, if they answer 'Yes' to either of the following questions, MUST ALSO file a Personal Property Tax Return. If this applies to your business entity, please file both the Annual Report and Business Personal Property Return together.

- Does the business own, lease, or use personal property located in Maryland?
- Does the business maintain a trader's license with a local unit of government in Maryland?

To file electronically, go to Maryland Business Express at <https://egov.maryland.gov/businessexpress> – search by your unit's name or your Dept ID.

You'll need to register the first time you visit, but the process is quick and easy.

In the red box on the left, you'll find a link to file your report:

Please go [HERE](#) to file your Annual Report. A 2-month **extension request** for filing the Annual Report and Personal Property Tax Return may be filed [here](#).

All PTAs are "Domestic Non-Stock Corporations."

Once you've filed for your unit online, the SDAT's online filing system allows you to pull up that information as your starting point the next year. You also can print copies of filings or save them as pdfs, which is highly advisable, even though it's easy to confirm filing and access the information included in the report at any time using that feature of SDAT's website.

Please provide a copy to Free State PTA via Givebacks.

If you find your PTA's charter has been forfeited, please contact PTA Council for help reviving your unit. To check the status of your PTA, use the Entity Search feature of Maryland Business Express: <https://egov.maryland.gov/BusinessExpress/EntitySearch>.

In a landmark collaboration, the PTA Council is working alongside BCPS's Office of Family and Community Engagement, the League of Women Voters, and Youth Service America by offering a mix of direct, indirect, and advocacy-based opportunities. Our goal is threefold: intentional connection, collaborative training, and elevating middle school service.

PTA Council's FSCP Committee's Community Partners Subcommittee plays a key role in the PTA/BCPS service-learning partnership and the Global Youth Service Day launch. We are seeking area PTA/PTSA leaders, student council representatives, student advocates, and dedicated community members to join us in the strategic rollout of the pilot.

1. Beth has continued to write testimony for FSPTA during the 2026 General Assembly – a key Council-supported bill relates to healthy school start times.
2. Beth planned a successful FSPTA Advocacy Day in Annapolis on 2/17. Attendees met with legislators to discuss legislative priorities during the day and enjoyed an evening reception for legislators and PTA leaders.
3. PTA Council was represented at National PTA's Legislative Conference (LegCon), March 2-4, by Treasurer Jayne Lee, who met with national legislators and shared PTA priorities.
4. The PTA Council Board of Directors voted to support legislation to keep councilmanic districts and school-board districts aligned.

GET PROTECTED AGAINST **MUMPS**

Talk to your provider or visit our health centers to receive the **MMR (measles, mumps, and rubella) vaccine**.

Baltimore County Health Centers are able to vaccinate both adults and children with the MMR vaccine (measles, mumps and rubella). Adults who have never been vaccinated with MMR should have their first dose as soon as they can and a second dose 4 weeks later. Children should receive their first dose at 1 year and their second dose at 4 - 6 years.

Mumps can be serious, and result in: Inflammation and pain of the testicles or ovaries in adults, and in rare cases may cause male infertility. Other rare complications include inflammation of the brain, hearing loss, and inflammation of the pancreas.

Keeping Your PTA Out of Politics!

An important reminder: PTA, which are non-profits, aren't allowed to endorse candidates.

To be tax-exempt under section 501(c)(3) of the Internal Revenue Code, an organization must be organized and operated exclusively for exempt purposes set forth in section 501(c)(3). It may not be an action organization, i.e., it may not attempt to influence legislation as a substantial part of its activities and it may not participate in any campaign activity for or against political candidates.

Section 501(c)(3) organizations are restricted in how much political and legislative (*lobbying*) activities they may conduct. For a detailed discussion, see [Political and Lobbying Activities](#).

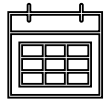

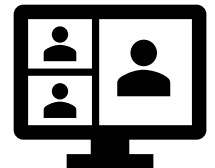
