There's been progress with **the new Free State PTA and the former Maryland PTA.** Free State PTA is up and running, and federal/state court cases are advancing against the former Maryland PTA. PLEASE FILL OUT THE CONSENT FORM TO BE TEM-PORARILY UNDER THE DELAWARE PTA GROUP EX-EMPTION TO AVOID LOSING YOUR TAX-EXEMPT STATUS!

Free State PTA has its tax-exempt status, but due to a federal IRS moratorium, can't currently use a group exemption. Since you're a PTA and the **old** state organization isn't, you risk losing your tax-exempt status unless you fill out the form.

Despite the change from the old state PTA organization to Free State PTA, your **financial responsibilities** haven't changed. You're still Free State PTA: www.fspta.org National PTA: www.pta.org

responsible for filing all tax forms, as well as your Maryland Charitable Solicitations Act filing. For help, contact Emory Young (<u>extension@bcptacouncil.org</u>) or feel free to contact me.

IMPORTANT INFORMATION TO PROTECT YOUR UNIT!

In early January, we resent **important documents from National PTA and Free State PTA**. We also printed them and put them into BCPS interoffice mail before winter break.

PLEASE KNOW that these complicated matters created by the former Maryland PTA are being resolved and that your unit is safe and supported. You simply need to take some steps to assist in the transition. Guidance is available on the Free State PTA website, <u>www.fspta.org</u>.

 \Rightarrow **Review your bank account for any unauthorized withdrawals:** Withdrawals (likely \$98 and \$3) from "Maryland Interac MD GovPay" have been reported to Free State PTA. Neither National PTA nor Free State PTA made them.

 \Rightarrow IRS Letter of Determination (proof of non-profit status): Free State PTA can't currently use a group exemption due to an IRS moratorium. National PTA has proposed a *temporary solution* to allow PTA units to be covered by Delaware PTA's group exemption. You'll still be a Maryland corporation and file all Maryland tax forms. There will be no obligations to Delaware or changes in your day-to-day operations. EVERY UNIT PRESIDENT must complete, sign, and email to Free State PTA the CONSENT FORM found on the Free State PTA website's homepage.

 \Rightarrow IRS Form 990 (due on 11/15/21): Despite inappropriate actions by the former Maryland PTA to delete local units and councils in Maryland from the existing group exemption (National PTA is addressing this issue via the court system), your annual Form 990 must still be filed. When filling out the form, use the Group Exemption Number 1999 for the Maryland Congress of Parents and Teachers Association, Inc.

BOOK DONATION PROJECT: ARBOR INITIATIVE

In Summer 2020, a group of Dulaney High students started the non-profit Arbor Initiative to collect and donate books to K-8 students.

Arbor Initiative has partnered with over 15 different schools and non-profits to donate over 5,000 books to children in need.
