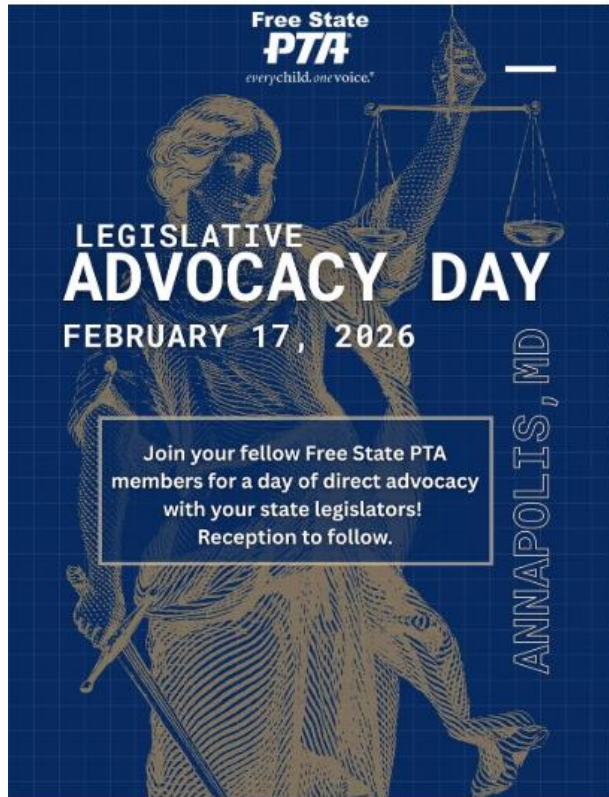

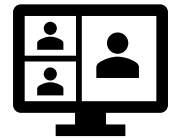

## Partnership Spotlight: Baltimore County Health Department

PTA Council is proud to announce that we've reestablished a partnership, started in 2014, with the Baltimore County Department of Health (BCDH). The goal then and now is to educate families on critical issues relating to students' health.

In 2026, PTA Council will take part in the BCDH Tobacco Program's health communications campaign to share information on the dangers of electronic smoking devices.

PTA Council and representatives from PTAs throughout BCPS will take part in a focus group to help create educational materials to reach target populations.

We also plan to share BCDH information through our bulletin and social media, and host BCDH presenters at our March General Membership Meeting, which always has a health and safety focus.

## Keeping Your PTA out of Political Endorsements!

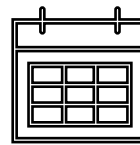
An important reminder: PTA, which are non-profits, aren't allowed to endorse candidates.

To be tax-exempt under section 501(c)(3) of the Internal Revenue Code, an organization must be [organized](#) and [operated](#) exclusively for [exempt purposes](#) set forth in section 501(c)(3). It may not be an [action organization](#), i.e., it may not attempt to influence legislation as a substantial part of its activities and it may not participate in any campaign activity for or against political candidates.

Section 501(c)(3) organizations are restricted in how much political and legislative (*lobbying*) activities they may conduct. For a detailed discussion, see [Political and Lobbying Activities](#).

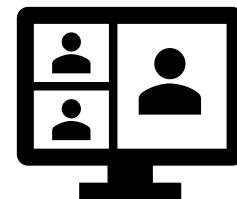
