#### **FINANCIAL REVIEW**

It's best to get your unit's review (audit) done in July or August (after the end of your 6/30 fiscal year but before your first general meeting) so your board can work on its 2022-23 budget.

Select a committee of at least 3 people who do not have check-signing authority.

Your budget should be presented to your members at your first General Meeting.

# STANDARDS OF CONTINUING AFFILIATION (SoCA)

To be in "good standing," you must carry out your legal/fiduciary responsibilities:

- file federal tax return
- file MD Charitable Solicitations Act report
- file MD Personal Property Tax Report
- pay dues to National PTA and Free State PTA
- Submit bylaws to FSPTA by 6/1

# CONSENT FORM TO JOIN DELAWARE PTA NOW DUE 5/13

Due to an IRS moratorium, Free State PTA can't currently use a group exemption, so to retain your non-profit status, you must TEMPORARILY be covered by Delaware PTA's group exemption. You'll still be a MD corporation, file all MD tax forms, and have no obligations to DE. Your day-to-day operations won't change.

### FROM PTA COUNCIL'S ADVOCACY/LEGISLATION COMMITTEE

PTA Council has partnered with the Student Support Network (SSN), a non-profit which supports in-need BCPS students, since SSN's inception. From their newsletter:

"We've been hard at work advocating for our "Road Map to End Hunger in 2022" and have made significant progress! Governor Hogan recently added \$4.8 million in state funding for Summer SNAP for Children and the Baltimore County Executive's budget also includes a big increase in funding for Baltimore County kids this year. As a result, more than 10,000 children in the county will receive the \$100 food supplement this year - a significant improvement from last year, when just 450 children received the benefit.

Thank you to the SSN volunteers who provided testimony at every single one of the Baltimore County budget hearings. A special thanks is also in order for the **Baltimore County PTA Council** and NAACP for their support of a fully funded Summer SNAP for Children program. While progress has been made, we continue to advocate for a fully funded program so that all of the more than 60,000 eligible children in very low-income families can participate."
