- Upload financial review into Givebacks

## Standards Of Affiliation (SoA)

In addition to paying member dues and providing officer contact information to Free State PTA (FSPTA), you must take care of the following:

- ✓ **BYLAWS:** Bylaws need to be reviewed at least every 3 years and submitted to FSPTA for approval.
- ✓ **FINANCIAL REVIEW (AUDIT):** All PTAs must conduct an annual financial review which is due to FSPTA by 10/30.
- ✓ **INSURANCE:** Every PTA unit in Maryland must have insurance coverage through AIM. Enrollment forms were emailed to all PTAs. Coverage ends 6/30/26.
- ✓ **IRS 990:** Every PTA must file annually by 11/15. If annual gross income was \$50,000 or less, you can submit the 990N e-postcard.
- ✓ **MARYLAND CHARITABLE SOLICITATIONS ACT:** As a charitable organization soliciting in MD, your unit must file documents with the Secretary of State. Registration is required prior to the commencement of solicitations (for new units) and an annual update is required by 12/30.
- ✓ **INCORPORATION/MD PERSONAL PROPERTY REPORT:** All local PTAs must be incorporated in MD. To maintain your incorporation status, a Personal Property Report must be filed by 4/15 each year if your PTA owns any property or not.

***For all shared documents, be sure to keep copies for yourself!***

**FSPTA requires that units submit SoA documents via Givebacks!**

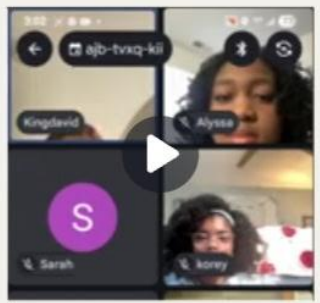
### School-based Highlights!

### Policy 1250 Approved: Protecting All Students

After months of advocacy and testimony from PTA Council and community allies, the BCPS Board of Education has voted and approved Policy 1250. This policy ensures that schools remain focused on education, not immigration enforcement. Key protections of Policy 1250 include:

- **Warrant Requirement:** ICE agents are prohibited from entering school grounds or bus stops without a judicial warrant.
- **Privacy:** Staff may not ask for or require information regarding the immigration status of students or families.
- **Mandatory Training:** All BCPS employees will receive annual training on enforcement response protocols.
- **Student Support:** Schools must provide trauma-informed counseling resources for students in mixed-status families.

We extend our gratitude to Board Member Christina Pumphrey (former PTA Council Central-area VP) for her public leadership throughout this process.

In the coming year, the Council’s JEDI Committee will focus on accountability and implementation of Policy 1250.

We’re committed to collaborating with the district and community partners to ensure these protections are clearly communicated and that every campus remains a safe, accessible space for every student.

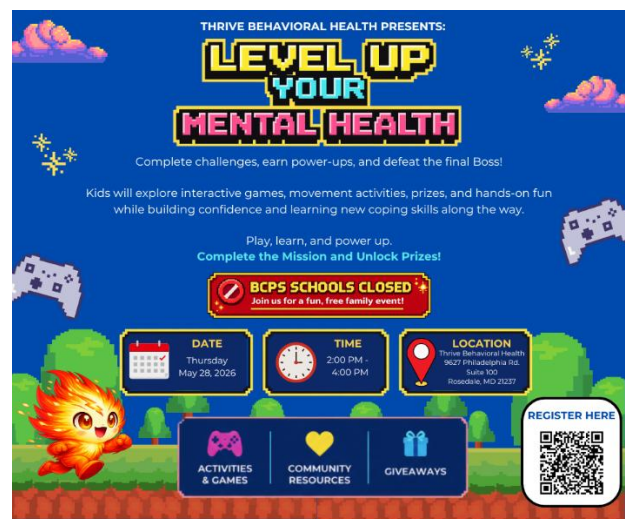

School-based health centers (SBHC) provide primary care in the schoolhouse to help keep students healthy and ready to learn. All BCPS schools have a school nurse in the health suite. Some BCPS schools also have an SBHC with a health care provider that can see students for well-child exams/sports physicals, sick visits, vaccines, health screenings, and much more. All students that attend a school with an SBHC are eligible to enroll, regardless of insurance.
