## **Standards Of Continuing Affiliation**

In addition to paying member dues and providing officer contact information to Free State PTA (FSPTA), you must complete the following:

- ✓ **BYLAWS**: Bylaws need to be reviewed at least every 3 years and submitted to FSPTA for approval. All units should have submitted bylaws to FSPTA by 6/1/22. If you still need to do this, use the template here: https://www.fspta.org/bylaws
- ✓ FINANCIAL REVIEW (AUDIT): All PTAs must conduct an annual financial review (due 10/30) and email a copy to FSPTA at jlee@fspta.org. Refer to "Cash Encounters" in the Finances section of our website for a sample report.
- ✓ **INSURANCE**: Every PTA unit in Maryland must have insurance coverage through AIM. Enrollment forms were emailed to all PTAs. Coverage ended 6/30/22. See the PTA Council website's Finances/Insurance section for details.
- ✓ IRS 990: Every PTA must file annually by 11/15. If annual gross income was \$50,000 or less, you can submit the 990 e-postcard. Provide a copy of the 990 filing to FSPTA at jlee@fspta.org. More details here: https://www.irs.gov/charities-and-nonprofits
- ✓ MARYLAND CHARITABLE SOLICITATIONS ACT UPDATE: As a charitable organization soliciting in Maryland, your unit must file documents with the Office of the Secretary of State. Registration is required prior to the commencement of solicitations (for new units) and an annual update is required.

✓ INCORPORATION/MARYLAND PERSONAL PROPERTY TAX RETURN: All local PTAs must be incorporated in Maryland. To maintain your incorporation status, a Personal Property Tax Return must be filed by April 15 each year if your PTA owns any property or not. Send a copy to FSPTA at jlee@fspta.org. Check your status at: www.dat.state.md.us. If your unit is not incorporated or the incorporation needs to be revived, contact FSPTA.

For all shared documents, be sure to keep copies for yourself!

#### PTA INSURANCE

Unit presidents should have received invoices from AIM via email.

Free State PTA offers low-cost insurance (\$226/year) to local units. Your package has not changed. Your payment to AIM was due on July 1. If you need help, contact 1-800-876-4044 or Pamela Brizendine at pbrizendine@aim-companies.com

#### IMPORTANT FINANCE-RELATED INFORMATION

Your federal tax forms are due by November 15th. If your gross receipts are under \$50,000, you're eligible to e-file the 900N, known as the e-postcard. For most units, the 990-EZ can be filed (for those with gross receipts under \$200,000). For those with gross income over \$200,000 and below \$500,000, the IRS Form 990 is necessary. Anyone eligible to use the 990-N or 990-EZ can choose to file Form 990. Here's a link to IRS FAQs:

Your Maryland Charitable Solicitations Act Annual Update is due by December 31st. The form is mailed with a signed copy of your 990 or 990-EZ or Form COF-85 if you used the 990-N. #### IRS Form 990-N Update: New Sign-in Process

Beginning August 2022, smaller charities that are eligible and choose to file Form 990-N, Electronic Notice for Tax-Exempt Organizations (e-Postcard), must sign into the IRS modernized authentication platform using either their active IRS username or create an account with ID.me, the current IRS credential service provider.

When accessing the Form 990-N submission page, Form 990-N filers have three options:

- 1. **Sign in with their active IRS username:** Users with an active IRS username have the option to access the Form 990-N submission page using their existing IRS credentials or they can choose to create a new account with ID.me.
- 2. **Sign in with their existing ID.me account:** Users that have an ID.me account to access other IRS online services or from a state or federal agency can sign in using their existing ID.me account.
- 3. **Create a new ID.me account:** Users that don't have an active IRS username credential must register and sign in with ID.me.

ID.me account creation requires an email address and multifactor authentication. Form 990-N filers who have an existing IRS username and register for an ID.me account must use the same email address.

For Form 990-N filing instructions, see <u>Publication 5248</u>, Form 990-N <u>Electronic Filing System User Guide</u> (PDF).

The filing process has not changed for organizations that file <u>Form 990</u>, Return of Organization Exempt from Income Tax, or <u>Form 990-EZ</u>, Short Form Return of Organization Exempt From Income Tax.

#### Free Online Training for Small to Mid-Sized Section 501(c)(3) Charities

The IRS provides interactive online training to help officers, board members and volunteers maintain your organization's Section 501(c)(3) tax-exempt status - including a course on filing Form 990-series annual returns. The Virtual Small to Mid-Sized Tax-Exempt Workshop at StayExempt.irs.gov is an important resource for all charities, old and new.

On October 26, PTA Council and the Area Education Advisory Councils (AEAC) co-sponsored a virtual Board of Education Candidates forum.

The timing was perfect – the day before early voting began – to hear candidates' opinions on a wide variety of issues, including behavior and discipline policies, academic performance, transportation and facilities issues, and BOE/Administration interactions.

Attendees heard from 7 of 8 candidates running in Councilmanic districts with 2 candidates vying for a BOE seat (Districts 1, 2, 3, and 4; only one candidate is on the ballot in Districts 5, 6, and 7).




# A Message from PTA Council's Partner, The Baltimore County Health Department

According to the 2018 Maryland Youth Risk Behavior Survey (YRBS), 18.4% of Baltimore County high school 9th graders reported ever using cannabis in their lifetime. More than twice as many Baltimore County 12<sup>th</sup> graders reported lifetime cannabis use (44.4%). Compared to their peers statewide, Baltimore County high school students reported similar rates of lifetime cannabis use across all grades.
