#### **Some specifics about Reflections:**

Reflections offers students Pre-K to Grade 12 the opportunity to create original works of art in 6 categories: **dance choreography, film production, literature, musical composition, visual arts, and photography.**

A total of 4 entries per age division (Primary (Pre-K-Grade 2), Intermediate (Grades 3-5), Middle (Grades 6-8), High (Grades 9-12), Special Artist (All Grades)) in each of the 6 categories can be submitted to PTA Council for judging in early January.

Entries receiving County Awards of Excellence are forwarded to Maryland PTA for judging. The state forwards Outstanding Interpretation entries to National PTA for judging. Participants are recognized at each level.

**PTA COUNCIL PARTNER STUDENT SUPPORT NETWORK**

Since Student Support Network's (SSN) creation in 2015, PTA Council has supported this non-profit which provides basic necessities to BCPS students in need. Before the pandemic, SSN ran "rooms of support," under the guidance of school administrators, social workers, and guidance counselors, to give the most in-need students (many of whom are homeless) food and basic life necessities. When schools closed in March, SSN pivoted to create food and necessity distribution sites. Every week, volunteers man three sites: Owings Mills High School, Parkville High School, and Loch Raven Technical Academy. Any and all in need are welcome to drive up every Friday morning for pick-up.

**PTA COUNCIL ADVOCACY WORKS!  
CEP MEAL PROGRAM IMPLEMENTED FOR BCPS SCHOOLS!**

CEP stands for the Community Eligibility Provision, a federal meal program for students in need. We've advocated for this program for a number of years at Board of Education (BOE) meetings and with County and State legislators. The BOE at its July 14, 2020 meeting voted unanimously to direct the Superintendent to elect CEP for the 66 BCPS schools currently eligible.

Schools electing CEP offer breakfast and lunch at no charge to all students at schools with a certain percentage of students in poverty. No more lunch-shaming, meal card debt, and paperwork to fill out for students attending these schools.

All of the schools below, and at least 20 more, will be able to offer meals at no charge to ALL students, which will comprise at least 30% of all BCPS students:

**MEMBERSHIP DUES: Council Dues Due October 1**

Dues bills are only \$1 per unit this year, as voted upon by the PTA Council Board of Directors at our August meeting, recognizing the issues created by COVID-19. We can't completely waive dues because of a stipulation in our bylaws (dues would have been .50/member based on 2019-20 membership numbers). Council dues are separate from Maryland PTA and National PTA dues. **Some units owe dues from last year and will be contacted separately.**

National PTA dues are \$2.25/member to National PTA and \$2.00/member to MDPTA.  
Each unit remits dues monthly in the amount of \$4.25/member to MDPTA.

**STANDARDS OF CONTINUING AFFILIATION**

**FINANCIAL REVIEW:** Every PTA must conduct an annual financial review and send a copy to MDPTA, 5 Central Ave, Glen Burnie, MD 21061. Refer to MDPTA "Cash Encounters" in the Finances section of our website for a sample report.

**IRS 990:** Every PTA must file annually by 11/15. If annual gross income was \$50,000 or less, you can e-file the 990 e-postcard. Provide a copy of 990 filing to MDPTA. For assistance, contact MDPTA at 410-760-6221.

**INSURANCE:** Every PTA unit in Maryland must have insurance coverage through AIM. Enrollment forms were sent to all PTAs; form can be downloaded at [www.mdpta.org](http://www.mdpta.org). Coverage ended 6/30/20. Please see the Finances/Insurance section of the PTA Council website for details.

**INCORPORATION:** All local PTAs must be incorporated in Maryland. To maintain your incorporation status, a Personal Property Tax Return must be filed by April 15th each year whether or not your PTA owns any property. Check your status here: [www.dat.state.md.us](http://www.dat.state.md.us). If your unit is not incorporated or the incorporation needs to be revived, contact MDPTA at 410-760-6221.

**BYLAWS:** Need to be reviewed at least every 3 years and submitted to MDPTA for approval. For assistance revising, contact [bylaws@bcptacouncil.org](mailto:bylaws@bcptacouncil.org).
